Under State regulations, the City of Page cannot perform burials without receiving a Burial/Transit Permit from the mortuary in charge or a family member. This must be given to the City caretaker prior to interment.

A grave liner is required for all interments. The liner must be delivered to the cemetery at least one hour prior to the time of interment.

Standard Headstone sizes: Interment-single 12"x40"; Double-19"x40"; Urn-Single 12"x16"; Urn-Double 14"x36"; Infant-12"x20"

Plaque-5"x9"

Stone sizes are typical, but vary in size. Please inquire as to what may be a maximum size that can be installed.
