

ORDINANCE NO. 693-22

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, AMENDING THE ZONING CLASSIFICATION OF PARCEL NO. 80218008Y FROM PLANNED DEVELOPMENT (PD) TO SERVICE COMMERCIAL (SC).

WHEREAS, the City of Page Planning and Zoning Commission held a public hearing on Zoning Case No. ZON 22-003 on April 11, 2022, to consider amending the zoning classification from Planned Development District, (PD), to the zoning classification of Service Commercial (SC); and

WHEREAS, due and proper notice of such public hearing before the City of Page Planning and Zoning Commission was given in the time, form, substance and manner provided by law; and

WHEREAS, the City of Page Planning and Zoning Commission has unanimously recommended the adoption of Zoning Case No. ZON 22-003 as aforesaid; and

WHEREAS, the Mayor and City Council have determined that the zoning classification amendment conforms to the City of Page General Plan, and after considering the individual property rights and personal liberties of the residents of the City, and the probable impact of the proposed zoning on the cost to construct housing for sale or rent, desire to accept the recommendation of the City of Page Planning and Zoning Commission and rezone Parcel No. 80218008Y, which is approximately 6.51 acres as further defined as Tract A, Block 281, a Minor Subdivision of the City of Page, 06 Township: 40 Range: 09E, Gila and Salt River Meridian, Coconino County, Arizona, as more particularly described in Exhibit A; and

WHEREAS, A.R.S. § 9-802 allows a City to adopt a code or public record by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, as follows:

Section 1. The legal description of Parcel No. 80218008Y attached hereto as Exhibit A and incorporated herein by reference, are hereby declared a public record. A minimum of one paper copy and one electronic copy of Exhibit A shall be maintained in compliance with A.R.S. § 44-7041 in the office of the City Clerk and shall be available for public inspection during normal business hours.

Section 2. The zoning classification of Parcel No. 80218008Y, which is approximately 6.51 acres as further defined as Tract A, Block 281, a Minor Subdivision of the City of Page, 06 Township: 40 Range: 09E, Gila and Salt River Meridian, Coconino County, Arizona, as more particularly described in Exhibit A,

is hereby amended from the zoning classification of Planned Development District, (PD), to the zoning classification of Service Commercial District, (SC). Development shall be in accordance with all applicable regulations.

Section 3. That the City of Page Zoning Map is hereby amended to reflect the zoning classification change.

Section 4. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed, effective thirty (30) days from the adoption hereof.

Section 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by the decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

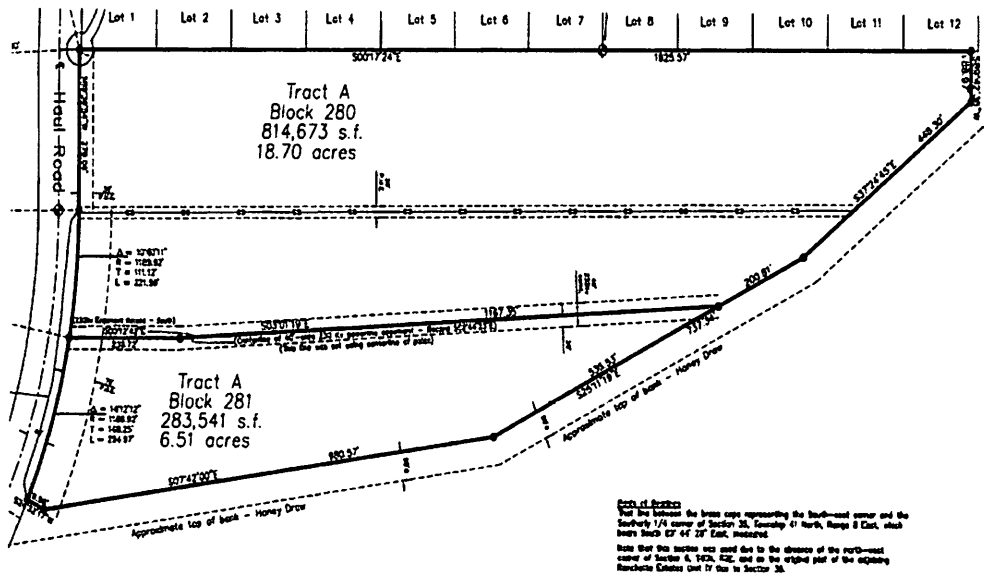
