## FILING YOUR PAPERS

**You must file the following documents with the City Clerk's Office between 03/09/20 and 04/06/20:**

- ✓ Nonpartisan Nomination Paper Declaration of Qualification
- ✓ Nonpartisan Nomination Petitions signed by **at least 108 and no more than 216** City of Page registered voters
- ✓ Financial Disclosure Statement

# CANDIDATE CAMPAIGN FINANCE

## TO BEGIN THE PROCESS

- ★ **IF** you plan to receive or expend, *in any combination*, **more than \$500.00** during the election cycle, you must file a Statement of Organization. The election cycle is 01/01/19—12/31/20.
- ★ Be sure to maintain all records because **IF** you go over the \$500.00 limit during the election cycle, you must file a Statement of Organization within 10 days.

Campaign Finance Reports will be due periodically, as indicated on the Campaign Finance Cover Sheet. While the City Clerk's Office may send a reminder to the e-mail listed on the Statement of Organization, **it is the responsibility of the candidate to ensure reports are filed timely.**
