The agreement made this 17th day of JUNE, 2019~~20~~ between CHALLENGER SPORTS CORP or its assignees, a corporation organized and existing under the laws of the State of Kansas, located at 8263 Flint, Lenexa, KS 66214 and herein referred to as "Challenger International Soccer Camps" and:

WHEREAS:

1.0 Conditions: "Challenger International Soccer Camps" agrees that it will conduct and maintain an instructional soccer camp in accordance with the following:

- Coaches will hold the minimum of a FA licence or a USSF licence or a Challenger International Soccer Camp certification.
- There will be at least one qualified coach for each coaching group (12-15) of campers.
- Each camp shall include five daily sessions Monday through Friday or other as specified. Sessions shall run for one hour, one and a half hours, three hour and six hours.

1.1 Term of Agreement – please circle all appropriate camp programs and fees.

Camp fees: For 1 hour \$ 85 1.5 hours \$ _____ 3 hours \$ 140 6 hours \$ 185

(For any camper registering after the ball and shirt order has been taken 10 days before camp, there will be a \$10 late fee charged).

1.2 Provisions: "Challenger International Soccer Camps" shall provide the following to the Client:

- Access to 20 free skills videos through the new iChallenge/TOPYA app - Available to ALL players within "The Club".
- One coaches clinic/special coaching session per week of camp, two hours in length, at no charge to "The Client" during the week of camp.
- A certificate of general liability coverage to all camps.
- Promotional literature, posters and operational and marketing support for your selected program.
- A hand stitched soccer ball and T-shirt to each camper who registers for camp – unless otherwise stated.
- A replica Soccer jersey to all campers who register on line before the early sign up deadline of 30 days
- The Camp coordinator will receive a free camp scholarship and free replica jersey.
- All host families will receive a rebate of \$80 towards the cost of their camp fees.

2.0 Conditions accepted by the "The Client":

- To provide an outdoor soccer field or training area which are deemed safe and suitable for instructional purposes. Approximate requirements, one field per campers.
- Client agrees that should payment not be made within 60 days from the invoice date (6 weeks after camp) a finance charge of 1.5% per month shall be applied the total amount due until paid in full.
- Provide a Coordinator who shall be the local camp administrator and liaison between "Challenger International Soccer Camps:" and "The Client".
- Be responsible for the administration of camp applications and agrees to schedule equal numbers of campers to each half day session.
- Fourteen (14) days prior to camp "The Client" shall provide "Challenger International Soccer Camps", the number of camper registrations. **The number of coaches assigned will be based on this number.** Additional campers may be enrolled after this date subject to availability of coaches.
- Solicit host families from "the Client" to house "Challenger International Soccer Camp" coaching staff for the duration of the camp.

2.1 Non Solicitation: "The Client" agrees that it will not solicit the services of any member of the "Challenger International Soccer Camps" Coaching staff for employment independent of "Challenger International Soccer Camps."

The terms and/or conditions of this agreement may be amended by Challenger International Soccer Camps with 30 day written notice. Dates selected are subject to availability.
