

**ORDINANCE NO. 724-24**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, AMENDING SECTION 31.59 (D) OF THE CITY OF PAGE CODE OF ORDINANCES, AMENDING PURCHASING AUTHORITY LIMITS FOR PAGE UTILITY ENTERPRISES.**

**WHEREAS, the City Council desires to amend the purchasing authority limits for the Page Utility Enterprises Board and General Manager to allow Page Utility Enterprises to function more effectively.**

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, as follows:**

**Section 1: That Section 31.59 (D) of the City of Page Code of Ordinances is hereby amended as follows:**

**(D) Purchasing. PUE purchases shall be governed by the purchasing requirements of this subchapter, compulsory state law and the city code, except:**

**(1) The Utilities General Manager shall replace the City Manager as purchasing agent for PUE;**

**(2) Purchases above ~~\$20,004~~ \$300,000 shall be approved by the Board with a monthly notice of all such purchases to be directed to the Mayor and Council; and**

**(3) All purchases of ~~\$100,000~~ \$600,000 and above, excluding monthly power purchase obligations or other obligations required by Council approved contracts and agreements, are subject to Council approval.**

**Section 2: That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.**

**Section 3: That the effective date of this Ordinance shall be 30 days from the adoption of this Ordinance.**

**Section 4: If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.**

**Section 5:** That the City Clerk is authorized to correct typographical and grammatical errors, as well as errors of wording and punctuation, as necessary; and that the City Clerk is authorized to make formatting changes needed for purposes of clarity and form, if required, to be consistent with the Page City Code of Ordinances.
