ORDINANCE NO. 728-24

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, AMENDING SECTION 154.041 OF THE CITY OF PAGE CODE OF ORDINANCES, ADDING STREET LIGHT REQUIREMENTS.

WHEREAS, the City Council desires to standardize the spacing requirements for street lights in new developments throughout the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, as follows:

Section 1: That Section 154.041 of the City of Page Code of Ordinances is hereby amended by adding a subsection C as follows:

§ 154.041 GENERAL REQUIREMENTS.

(C) Developers of all residential, commercial, industrial or other types of properties are responsible for the cost of design, materials, and installation of street lighting on all streets within and adjacent to their development site(s). Street lighting plans shall be prepared and sealed by a licensed electrical engineer registered in the State of Arizona. The street lighting design shall be reviewed and approved by the Site Plan Review Committee. Street light spacing shall be at intervals not to exceed 300'. Intersections shall have the minimum number of street lights installed based upon Table 1.

Table 1

Intersection Type	Minimum Street Light Quantity
Local/Local or Local/Private	1
Local/Collector, Collector/Collector, or Local/Arterial	2
Arterial/Collector	3
Arterial/Arterial	4

<u>Section 2</u>: That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

<u>Section 3</u>: That the effective date of this Ordinance shall be 30 days from the adoption of this Ordinance.

Section 4: If any section, subsection, sentence, clause, phrase or portion of

this Ordinance or any part of the Code adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

<u>Section 5</u>: That the City Clerk is authorized to correct typographical and grammatical errors, as well as errors of wording and punctuation, as necessary; and that the City Clerk is authorized to make formatting changes needed for purposes of clarity and form, if required, to be consistent with the Page City Code of Ordinances.
