

RESOLUTION NO. 1324-24

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 30, 2024.

WHEREAS, the City of Page, Coconino County, Arizona held a primary election on the 30th day of July, 2024 for the election of a Mayor and three (3) Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the city council pursuant to Arizona Revised Statutes §§ 16-642 and 16-646; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Page, Coconino County, Arizona, declare the results of the election, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the polls list or reported by the county, was 1,312 (see Exhibit A).

SECTION 2. That the number of ballots rejected was 0.

SECTION 3. That the votes cast for the candidates for councilmember were as follows:
