

ORDINANCE NO. 743-25

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, AMENDING THE CITY OF PAGE CODE OF ORDINANCES ADDING § 31.26, AIRPORT ADVISORY BOARD.

WHEREAS, the City Council desires to create an Airport Advisory Board to advise and make recommendations to the City Council regarding the operation and maintenance of the municipal airport.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, THAT THE CITY OF PAGE CODE OF ORDINANCES IS HEREBY AMENDED AS FOLLOWS:

SECTION 1. That § 31.26, AIRPORT ADVISORY BOARD, is hereby added to the of the City of Page Code of Ordinances as follows:

§ 31.26 AIRPORT ADVISORY BOARD.

(A) PURPOSE. THE AIRPORT ADVISORY BOARD WILL ACT IN AN ADVISORY AND REVIEW CAPACITY TO THE CITY COUNCIL REGARDING OPERATION AND CONSTRUCTION OF THE AIRPORT, AND SHALL HAVE THE FOLLOWING RESPONSIBILITIES AND DUTIES:

(1) TO ADVISE THE COUNCIL IN THE ESTABLISHMENT OF THE RULES AND REGULATIONS, CONSISTENT WITH STATE AND FEDERAL AVIATION AUTHORITY, AS MAY BE NECESSARY OR ADVISABLE FOR THE OPERATION AND MANAGEMENT OF THE MUNICIPAL AIRPORT, THE SAME TO BE CONFIRMED BY THE COUNCIL BEFORE THEY ARE PLACED IN EFFECT;

(2) TO ADVISE THE COUNCIL IN THE ESTABLISHMENT OF BUILDING SITES AND TO REQUEST REPAIR OR REMOVAL OF STRUCTURES NOT MAINTAINED IN ACCORDANCE WITH REGULATIONS AS TO CONSTRUCTION OR LOCATION; AND

(3) TO MAKE OTHER RECOMMENDATIONS AS MAY BE NECESSARY OR ADVISABLE FOR THE SAFE AND EFFICIENT MANAGEMENT, OPERATION, AND MAINTENANCE OF THE MUNICIPAL AIRPORT.

(B) MEMBERSHIP. THE AIRPORT ADVISORY BOARD WILL CONSIST OF SEVEN MEMBERS, APPOINTED PURSUANT TO § 31.05.

SECTION 2. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed, effective thirty (30) days from the adoption hereof.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this

ordinance is for any reason held to be invalid or unconstitutional by the decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

SECTION 4. That the City Clerk is authorized to correct typographical and grammatical errors, as well as errors of wording and punctuation, as necessary; and that the City Clerk is authorized to make formatting changes needed for purposes of clarity and form, if required, to be consistent with the Page City Code of Ordinances.
