

**ORDINANCE NO. 754-26**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, AMENDING SECTION 93.07 OF THE CITY OF PAGE CODE OF ORDINANCES, RELATING TO PARK HOURS.**

WHEREAS, the City Council has determined that it is in the interests of the City to amend § 93.07 PARK HOURS of the City Code of Ordinances, to allow for additional flexibility in meeting the seasonal demands and needs of the City's recreational areas.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAGE, COCONINO COUNTY, ARIZONA, as follows:

**Section 1:** That Section 93.07 PARK HOURS of the City of Page Code of Ordinances is hereby amended as follows:

**§ 93.07 PARK HOURS.**

~~Unless otherwise posted or by permit issued by the city, park hours for public use of all portions of any parks-recreation area, including off-street parking areas for the parks-recreation area, shall be from sunrise until 10:00 p.m.~~ THE CITY MANAGER IS AUTHORIZED TO ESTABLISH PARK HOURS FOR PUBLIC USE OF THE PARKS-RECREATION AREAS WITHIN THE CITY. No person may enter, occupy or use a parks-recreation area, including the off-street parking area, outside of park hours AS ESTABLISHED BY THE CITY MANAGER.

**Section 2:** That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**Section 3:** That the effective date of this Ordinance shall be 30 days from the adoption of this Ordinance.

**Section 4:** If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

**Section 5:** That the City Clerk is authorized to correct typographical and grammatical errors, as well as errors of wording and punctuation, as necessary; and that the City Clerk is authorized to make formatting changes needed for purposes of clarity and form, if required, to be consistent with the Page City Code of Ordinances.
